



Dear CUPE and STA Members:

In recent years, a number of situations have occurred where members of one of our Unions have found fault for one reason or another, with a member of the other Union. At some of these times, Union members have gone directly to management to lodge a complaint. We find this unacceptable. There is a longstanding CUPE/STA protocol which determines the process for a complaint regarding Union co-workers. Like the BCTF Code of Ethics, the CUPE Constitution and the School District Parent Appeal Process, the guidelines involved are purposeful and protective for ALL. We expect to be treated with respect and consideration if someone has a concern with us and we must ensure that we follow these guidelines when dealing with others.

Expected Process/Protocol

- 1. Speak directly to the co-worker involved (if this is impossible, you may write a note/letter).
- 2. If the situation is not corrected, speak to your Staff Rep (STA) or Shop Steward (CUPE).
- 3. If the situation is still not corrected, speak to the President (STA or CUPE).
- 4. If all of the above steps fail, then and **only** then, should a complaint be forwarded to management.

It is imperative that the process/protocol is followed carefully. It is important to all of us to work well together, regardless of our union affiliations.
